



MINUTES OF THE 92nd PARISH COUNCIL MEETING OF
MAPPLEBOROUGH GREEN PARISH COUNCIL

1. THE CHAIR DECLARED THE MEETING OPEN AT 6:30pm
2. APOLOGIES – Becky Howes Clerk, Cllr M Berry and County Cllr Rickhards
3. DECLARATIONS OF INTEREST – No Declarations made
4. PUBLIC FORUM:

Norman McLeod Resident, Karandeep Badwal Resident and Peter Hencher-Serafin

- a. Mr McLeod objected strongly to the planning submission regarding a hand carwash at the Sports Ground, on the grounds of increased traffic on the A435, insufficient parking provision, potential contamination of the Arrow and pointed out that the report issued by Seven Trent was made in 2016.
- b. Mr Badwal closely observed all discussions
- c. Mr Hencher-Serafin (Candidate for County Council election) made comments when requested through the Chair.

7. MATTERS ARISING

To receive feedback from Cllr's Cameron and Chadwick following attendance at Nalc Legal Team workshop March 2nd, 2019: Cllr's Chadwick and Cameron reported that the meeting was very well attended and covered a lot of ground, the two main points learned were:

- i. That the website must comply with the Government requirement that all public websites must be accessible to people suffering from visual, audio, or movement impairment.

ii. That it is against the law for the Parish Council to donate money to the church or it's upkeep.

b. Update regards Eastern Gateway developments, recent Stoford meetings

and to consider response to letter received from neighbouring Parish

Council: Considerable discussion took place regarding current revisions to outline planning permission being made by Stoford's to each Council and to the meeting held in Studley by Stoford's to answer questions from the Parish Councils.

Meeting notes are available, to view them please contact the clerk. It was generally agreed to invite a representative from the neighbouring parish to the next meeting.

c. To discuss and agree questions to be set for speaker at the Parish Assembly

Monday April 8th: It was agreed to base the questions unrelated GDPR

issues: Cllr Cameron apologised for not yet reconfiguring the email addresses on the Councillors personal machines but would try to do so before the next meeting.

Cllr Cameron also reported that he had spoken to the ICO regarding the Parish Council making use of the Clerk's home telephone and postal address and

publishing them on the website. The ICO advised that the Council should change this situation as soon as possible and that we should write to the Clerk explaining

what we were going to do and when. It was agreed that the Council will supply a second-hand mobile telephone for the Clerk and find a suitable Postal Address.

10. PLANNING APPLICATIONS:

Cllr Coley addressed the items below. The outstanding applications were considered, Clerk to action:

18/03745/FUL Outhill Farm, Hardwick Lane, Outhill

Dual purpose agricultural / equestrian building. No representation

19/00392/FUL New Oakdene, Birmingham Road

Erection of two storey extension. No representation

19/00439/FUL Hillcrest Farm, Pratts Lane

Agricultural building (retrospective). No representation

18/03626/FUL Lower Skilts Farm, Henley Road

Two storey rear extension, two new side windows and alteration to existing rear window. No representation

19/00036/FUL Studley Football and Social Club, Abbeyfields Drive

Change of use of part of car park to create a hand car wash facility.

The Parish Council strongly object to the planning application for the following reasons:-

Concern of pollution of the Arrow River and flooding

Traffic overspill causing problems to the residents of the Abbeyfields estate and users of the club

A similar car wash at the rugby club in Alcester has high usage at weekends which results in congestion problems on the A435. The same situation at this site could impact on the Washford turn off the A435.

18/03746/VARY Redditch Gateway Land Adjacent To The A4023 Coventry Highway East Of Ravensbank And Winyates Green Redditch

Proposal Variation of conditions 2 and 8 to amend the parameters of development for the northern development parcel, and Phase 1 Ground Engineering works (and changes to conditions 12, 16, 18, 21, 29, 31, 32, 36 and 37 to allow hedgerow and tree removal prior to the coming into effect of the relevant condition, and conditions 28 and 29 to relate to updated flood risk assessment) in respect of

Hybrid planning permissions 17/01847/OUT (Stratford reference number), 17/00700/OUT (Redditch reference number), and 17/00701/OUT (Bromsgrove reference number) dated 11 June 2018. Original description of

development (for 17/01847/OUT, 17/00700/OUT, 17/00701/OUT): 'Hybrid application comprising: Outline planning application (with matters of appearance, landscaping, layout, scale and details of internal circulation routes reserved) for the development on a phased basis of 32ha of employment land for business/industrial uses (Use Classes B1, B2, B8). The development shall include: landscaping, parking, associated infrastructure, utilities, drainage (including SUDS) and ground engineering works; And Full planning application for Phase 1 Ground Engineering works, and details of means of access to the site from the A4023' Mappleborough Green Parish Council object to the proposed variations submitted to Stratford District Council.

1. The change in of the proposed building does not follow the outline planning permission.

2. The potential increase in HGV volumes will negatively impact on the health and wellbeing of Mappleborough Green and Redditch residents through:

a. Increased particulate air pollution leading to poorer health.

b. Increased vehicle noise, leading to increased stress.

c. Increased through-night activity will result in residents suffering poor sleep.

3. The developer argues that this site is the only one suitable to their client in the West Midlands Region and that the development is necessary in order to meet economic forecasts. The council argue that there are many brownfield sites in Redditch and that the Council understand that unemployment is not a major problem (See report from the ONS re-benefit payments). The Council worry that this project is more about making money for a few rather than to meet a real need.

4. The original 'north side' application showed many more parking spaces 850 as opposed to 450 in revised application, part of the original reason was to meet employment needs, it seems the developer's client's needs outweigh the original needs of the area.

5. The developer argues that the site has walkways, cycle lanes and is on a public bus service route, however the council understand that the public bus service is already overcapacity and will require additional busses to meet an increased demand.

6. With the proposed increase in HGV's (assuming all of the loading bays will be in use) it is even more important that the hauliers follow the proposed routing plan, however the Parish Council do not believe a voluntary system will work and feel that the only certain way is a ban on HGV's over 7.5 tonne through Studley and Mappleborough Green. This ban could be temporarily lifted in the event of Problem on the M42.

7. The Parish Council are also concerned that the loss of trees, hedge rows and the re-routing of streams will have an effect on rare and protected wildlife that will not really be known until after the changes are made.

8. The council are concerned that when comparing drawings 5372-203K with BMT/2116/100- 01 drainage features do not correlate

9. The council fear that with 24-hour operations lighting will further pollute the night sky and insist that all baffles and shields are fitted as a matter of course rather than "if needed". The council would also prefer that all lighting units be fitted no higher than 10 metres.

Questions for the Developer

1. The Council would like the developer to explain what they mean by "comprehensive management plans" and "effective management regime" in reference to all planted areas and existing features that they have worked to retain.

2. The Council would like to understand how much of the materials to be used in the construction of the buildings will be recyclable or reclaimed.

3. The Council would like to know an estimated percentage of locally sourced construction materials.

4. The Council would like the developer to define the steps they will take to avoid using materials and surface treatments that give off harmful emissions and how they will manage the process. How the waste will be managed and if the materials will have any potential to harm the surrounding neighbourhood.

5. The Council would like to understand how the developer will control noise emanating from the site both during the construction phase and the operational phase. Since the operational service yard will be well lit it seems that there will be 24hour operations.

6. The Council fail to see how with such a potential increase in HGV's how the transport assessment remains unchanged and would expect the developer to explain their reasoning.
